ORDER

Vide paper read (1) above, the University invited applications for continuation of provisional affiliation for the academic year 2014-15 to colleges/courses affiliated to this University.

As per paper read (3) above the Principals of Ayurveda Colleges have applied for continuation of provisional affiliation for the academic year 2014-15.

Accordingly university has conducted inspection for continuation of affiliation for the college. On verification of the inspection report, it is found eligible to grant continuation of provisional affiliation to the college as they have remitted necessary fees and have been covered under the General Amnesty Scheme for the session 2014-15 by the Central Council.

Sanction has therefore been accorded by the Vice Chancellor by exercising the powers under Section 12(7) of Kerala University of Health Sciences Act, 2010 to grant continuation of provisional affiliation to the colleges listed below to conduct the following courses with annual intake of seats shown against each course during the academic year 2014-15 subject to the following conditions:

1. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will automatically be canceled.
2. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated
3. Affiliation granted is strictly provisional and only for the academic year 2013-14. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.

4. 4. The college should remit the annual administration fee fixed for UG/PG courses for this academic year 2013-14 within 10 days from the closure of admission.
5. 5. Admission to the next academic year shall be made only after obtaining prior permission from the University.
