## ORDER

- 1. Vide paper read (1) above, university invited applications for continuation of provisional affiliation for the academic year 2023–24 from colleges for the courses affiliated to the University. In response to the same, Principal, Vaidyaratnam Ayurveda College Ollur, vide paper read (2) above has submitted their application with necessary documents and remitted required fee.
- 2. Subsequently, University carried out an inspection at the college to assess the facilities available for conducting the UG(BAMS) course-75 seats and MD-Kaychikitsa-05 seats and the inspection commission submitted its report vide paper read (3) above.
- 3. Vide paper read (4) above, Scrutiny committee verified the inspection report and and recommended to grant Continuation of Provisional Affiliation to Vaidhyarathnam Ayuveda College, Ollur, for conducting following UG(BAMS) course-75 seats and MD-Kaycahikitsa-05 seats for the academic year 2023-24.

- 4. The matter of granting Continuation of Affiliation to Vaidhyarathnam Ayuveda College, Ollur was placed in the 75 th meeting of the Governing Council and vide decision read (5) above, Governing Council resolved to grant continuation of provisional affiliation to the college for conducting UG-BAMS course with 75 seats and MD-Kayachikitsa - 05 seats for the academic year 2023-24, subject to the receipt of Letter of Permission from the Ministry of AYUSH.
- 5. As per the paper read (6) above, Medical Assessment and Rating Board for Indian System of Medicine, NCISM, Ministry of AYUSH, Govt. of India has granted Conditional permission to Vaidhyarathnam Ayuveda College, Ollur, for intake capacity in UG BAMS with 60 seats (75 seats including EWS) and MD-Kayachikitsa - 4 seats (05 seats including EWS) for the academic session 2023-24 under section 28 of NCISM Act 2020.
- 6. In this circumstances, orders are hereby issued granting Continuation of Provisional Affiliation to Vaidhyaratnam Ayurveda College, Ollur for conducting BAMS with 75 seats and MD - Kayachikitsa - 05 seats for the academic year 2023-24, subject to the following conditions :-
- 1. The college shall comply with the conditions prescribed by the Medical Assessment and Rating Board for Indian System of Medicine, National Commission for Indian System of Medicine, in the permission order granting permission to the college for conducting UG/PG Degree/PG Diploma courses in Ayurveda during 2023-24 vide letter read (6) above.
- 2. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University / Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- 3. In the light of the direction of the Hon'ble Supreme Court of India in Writ Petition (C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.
- 4. Affiliation granted is strictly provisional and only for the academic year 2023-24. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- 5. The College should remit balance annual administration fee fixed for UG/PG course for the academic year 2023-24, if applicable.
- 6. Admission to the next academic year shall be made only after obtaining prior permission from the University.
