ORDER

- 1. University vide paper read (1) above, had invited applications for Continuation of Provisional Affiliation for the academic year 2024-25, from the colleges for the courses affiliated to the University.
- 2. In response to the same, Principal, Vaidyaratnam Ayurveda college, Ollur, vide paper read (2) above submitted their application with necessary documents and remitted required fee.
- 3. Subsequently, University carried out an inspection at the college to assess the facilities available for conducting UG and PG courses with requested seats, and the inspection commission submitted its report vide paper read (3) above.
- 4. Vide paper read (4) above, scrutiny committee verified the inspection report and pointed out some deficiencies in faculty position, number of patients at the college and the same were

communicated to the college as per the paper read (5) above.

5. In response to the same, the principal submitted a compliance report vide paper read (6) shove and the scrutiny committee examined the compilance reports in detail and found satisfactory. Thereby, scrutiny committee recommended to grant Continuation of Provisional Affiliation to Vaidyaratnam Ayurveda College, Ollur for conducting BAMS course with 75 seats and Ayurveda Vachaspati - Kayachikitsa with 05 seats for the AY 2024-25, as per the paper read (7) above.

6. The recommendations of the scrutiny committee were placed before the Governing Council meeting held on 29.05.2024 and vide decision read (8) above, the Governing Council resolved to grant Continuation of Provisional Affiliation to Vaidyaratnam Ayurveda College. Ollur for conducting BAMS and MD Kayachikitsa courses for the academic year 2024-25, subject to the receipt of Letter of Permission from the NCISM, Govt. of India, Ministry of AYUSH as follows:-

- 7. Vide paper read (9) above, the Medical Assessment and Rating Board for the Indian System of Medicine (NCISM), Ministry of AYUSH, Govt. of India has granted conditional permission to Vaidyaratnam Ayurvada College, Ollur for an intake capacity with 60 seats (75 including EWS) in UG (BAMS) course and 04 seats (05 seats including EWS) in 1 PG namely Kayachikitsa the academic session 2024-25 under section 28 of the NCISM Act 2020.
- 8. Vide paper read (10) above, in compliance to the Governing Council decision 62.09, the Principal, Vaidyaratnam Ayurveda College, Ollur has submitted an undertaking regarding the levying of GST, for the purpose of granting Continuation of Provisional Affiliation to the college for the AY 2024-25.
- 9. In these circumstances, orders are hereby issued granting Continuation of Provisional Affiliation to Vaidyaratnam Ayurveda College, Ollur , having permission from Medical Assessment and Rating Board for Indian System of Medicine, NCISM, Ministry of AYUSH, Govt. of India for conducting UG(BAMS) course with 75 seats and PG Degree course (Ayurveda Vachaspati - Kayachikitsa) with 5 seats for the academic year 2024-25.

The college shall strictly adhere to the conditions detailed in below :-

- i) The college shall comply with the conditions prescribed by the Medical Assessment and Rating Board for Indian System of Medicine, National Commission for Indian System of Medicine, in the permission order granting permission to the college for conducting UG & PG Degree courses in Ayurveda during 2024-25 vide letter read (9) above.
- ii) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University / Govt. of Kerala and on the basis of the direction issued by the



University from time to time, failing which the affiliation granted will be cancelled.

- iii) In the light of the direction of the Hon'ble Supreme Court of India in Writ Petition (C) 638/1998, the institution shall take appropriate measures for prevention of regging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.
- iv) Affiliation granted is strictly provisional and only for the academic year 2024–25. The college has to apply for continuation of provisional affiliation for the ensuing years by remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- v) The college should remit balance annual administration fee fixed for UG/PG courses for the academic year 2024–25, if applicable.
- vi) Admission to the next academic year shall be made only after obtaining prior permission from the University.
